## Notice

All the students of U.G/P.G. Courses are hereby informed that the ODD session starts from July to December-2020. Fee receipt will be downloaded/printed by the student online from his/her login. The Step wise procedure for the fee deposit is as under:-

### Fee Deposit (Cash/ Demand Draft)

- a) Students of Batch Upto 2014 Go to [www.gzsexam.com](http://www.gzsexam.com) & those of Batch 2015 to 2019 [www.mrsstuexam.com](http://www.mrsstuexam.com) Fill user ID & Password which is already used by the students for downloading their Semester fee slip. Go to student Area/Menu then click Receipt listing.
- b) Click on Receipt Number, download & print Fee Receipt.
- c) Print the Two (2) copies of Fee Receipt for depositing Fee in Bank.
- d) Deposit the Fee in any branch of Central Bank of India.

**The Fee should be deposited on the same day on which Fee Receipt is generated.**

- e) After depositing fee in the Bank, one copy of Receipt shall be retained by the student.
- f) Fees should not be deposited through RTGS/NEFT.
- g) Fees deposited through RTGS/NEFT will not be entertained.
- h) Student should deposit the fee mentioned in fee slip only.
- i) Students who applied Post Matric Scholarship on Ambedkar Portal should download their fee slip amounting Rs. 0 (Zero) by due date. Slip generated after due date will be considered with late fee.
- J) Demand draft of semester fees should be equal to the amount in the fee slip generated on your ID. If the amount of Demand draft is more than the amount in the generated fee slip than the excess fee will not be refunded.


